

# SOFWARE LICENSE AGREEMENT FOR IMACT - GENERAL CONDITIONS

By acceptance of any DISTRIBUTION COPY of IMACT, the LICENSEE acknowledges that the software included therein is LICENSED SOFTWARE and the LICENSEE thereby accepts and agrees to the terms and conditions set forth below as the sole terms and conditions regarding the use of such LICENSED SOFTWARE.

1. DEFINITIONS

For the purpose of this Agreement, when the following expressions commence with a capital letter, they shall have the following meaning:

**Agreement**: means this software license agreement and the Specific Conditions applicable to the Licensee, and their possible subsequent versions.

Licensor: means Rockwell Collins France or Rockwell Collins Inc. a part of Collins Aerospace (hereinafter referred to as "Collins Aerospace"), or any other individual or legal entity, who distributes rightfully the Software under the Agreement.

Object Code: means the java archive files originating from the compilation of the source code.

Parties: means both the Licensee and the Licensor.

Software: means the IMACT software modules "as is" when the Licensee accepts the Agreement or any third parties software included in IMACT as defined under annex A

Specific Conditions: means the Licensor commercial proposal as accepted by Licensee and including additional or derogatory terms and conditions.

Platform: means ATSU, CMU-900 and RIU/CMU-40x0

These expressions may be used both in singular and plural form.

#### 2. PURPOSE

- 2.1 Subject to acceptance of the present terms and conditions, Licensor grants to Licensee in consideration of the license fee per host set forth in the Specific Conditions, a non-assignable, non-exclusive, personal, non-transferable, license to install and use the Software (refer to Specific Conditions for the option chosen) in the operating entity premises designated herein, for the sole purpose of the customization of the Airline Operational Application ("AOC") can be installed on authorized Platform within Licensee's own fleet of aircraft and for the duration set forth in the Specific Conditions with rights to grant to the Licensee and its Customer, non-exclusive, non-transferable, non-assignable sub-license solely to use the Supply.
- 2.2 Title to the Software and documentation shall not pass to Licensee in any circumstances.
- 2.3 The Licensee is entitled to make one (1) copy for back up purposes. Any copy, other than those provided in this License is forbidden and shall be considered as an infringement of Licensor's copyright.

#### 3. ACCEPTANCE

- 3.1 The Licensee shall be deemed as having accepted the terms and conditions of this Agreement upon the occurrence of the first of the following events:
  - loading the Software by any or all means, notably, by downloading from a remote server, or by loading from a physical medium;
  - (ii) the first time the Licensee exercises any of the rights granted hereunder.
- 3.2 One written or electronic copy of the Agreement has been provided to the Licensee prior to its acceptance as set forth in Article 3.1 hereinabove, and the Licensee hereby acknowledges that it has read and understood it.

## 4. RESTRICTIONS

- a) Licensee agrees to treat all Software as copyrighted and as such agrees not to modify, correct, decompile, reverse engineer, attempt to deduce the source code, transfer, copy any Software and/or its master, unless otherwise provided in this License, without the prior written consent of Licensor, and not to cause or permit the Software or any part thereof to be disclosed to any person or entity other than Licensee for the Purpose of this License.
- b) The Software is not to be used in support of or on the behalf of any third party. Licensee may not provide, disclose, divulge or make available to, or permit use of the Software in whole or in part, by any third party without Collins Aerospace' prior written consent.
- c) This license does not allow Licensee's subsidiaries, parent companies, affiliates and/or agents the right to access and use the Software without prior written consent by Collins Aerospace.
- d) Licensee must monitor the physical or electronic distribution of the Software and ensure access to the Software at any given time is limited to access by Users at Licensee's premises, and all access to the Software is in compliance with U.S. export laws, restrictions, and regulations.
- e) Licensee may not install the Software on a shared drive or file server that can be accessed via the Intranet, Internet or other

similar means or other external network systems by other computers whether or not located on Licensee's premises or elsewhere.

f) Licensee may use the Software to support the aircraft owner/operator in accordance with the terms and conditions contained in this License. Licensee may make no further use of the Software without an additional License.

### 5. CONFIDENTIALITY

Licensee agrees to protect and maintain the confidentiality of the Software and any related documentation and shall not provide, disclose, distribute or otherwise make available any item of the Software in any form, to any person other than its employees having responsibility for using the Software in the scope AOC product.

Licensee shall take appropriate action by instruction, agreement or otherwise with its employees to comply with its obligations with respect to use, copying, protection and security of the Software.

#### 6. THIRD PARTY SOFTWARE

Licensee acknowledges the Software contains third parties software which are listed in ANNEX A of this document. The Licensee undertakes to apply and comply with the terms and conditions of license of those third parties software as indicated in ANNEX A of this document and to indemnify and hold Licensor harmless against all third party claims in this respect.

#### 7. LIMITED WARRANTY

Licensor warrants for the period referred to in the Specific Conditions that the Software, will substantially provide the functions(s) set forth in the Agreement.

Licensor will, at its sole option, without charge, endeavor to correct such nonconforming Software if available, or apply a bypass solution if available, to the Software within a reasonable time provided notice of the claimed defect is given to Licensor until the end of the warranty period. These corrections or bypass solutions shall only apply to the last release delivered by Licensor.

# The warranty shall be void:

- (i) if the Software or the host medium is exposed to any computer virus or to any use outside the scope defined in the Agreement;
- ii) if the Software or the host medium is not installed or operated in accordance with the Licensor's written instructions or specification defined in the Agreement;
- (iii) if the Software (or its host medium) is altered (or alterations are attempted), modified, corrected by other than Licensor.

The Licensee acknowledges that the scientific and technical state-ofthe-art when the Software was distributed did not enable all possible uses to be tested and verified, nor for the presence of possible defects to be detected. In this respect, the Licensee's attention has been drawn to the risks associated with loading, using, modifying and/or developing and reproducing the Software which are reserved for experienced users.

The Licensee shall be responsible for verifying, by any or all means, the suitability of the product for its requirements, its good working order, and for ensuring that it shall not cause damage to either persons or properties.

Licensee shall take any appropriate measure, under his responsibility, to reduce, as much as possible, the harmful consequences of any incident or malfunction, specifically with regard to the necessary backups and to submit in due time any difficulty to Licensor.

#### 8. NO OTHER WARRANTIES

The Licensee acknowledges that the Software is supplied "as is" by the Licensor without any other express or tacit warranty than those provided in Article 7. Licensor expressly disclaims in particular but not limited to any warranty as to its commercial value, its secured, safe, innovative or relevant nature, implied warranties of merchantability and fitness for a particular purpose or infringement, with respect to the Software, the accompanying product manual(s) and written materials, and any accompanying hardware.

Specifically, the Licensor does not warrant that the Software is free from any error, that it will operate without interruption, that it will be compatible with the Licensee's own equipment and software configuration, nor that it will meet the Licensee's requirements.

#### 9. LIABILITY

IN NO EVENT SHALL SELLER BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT OR CONSEQUENTIAL DAMAGES WHATSOEVER (INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF PROFITS, OR BUSINESS INTERRUPTION)



RELATING TO OR ARISING UNDER THIS CONTRACT AND/OR THE USE OF OR INABILITY TO USE THE LICENSED SOFTWARE DESCRIBED HEREIN, EITHER SEPARATELY OR IN COMBINATION WITH ANY OTHER PRODUCT, EQUIPMENT, SOFTWARE OR OTHER MATERIALS, EVEN IF SELLER HAS BEEN ADVISED OF THE POSSIBILITY OR CERTAINTY OF SUCH DAMAGES. SELLER'S TOTAL AGGREGATE LIABILITY HEREUNDER, WHETHER BASED UPON CONTRACT, TORT (INCLUDING NEGLIGENCE AND STRICT LIABILITY) OR OTHERWISE, SHALL IN NO EVENT EXCEED THE PRICE PAID BY LICENSEE HEREUNDER.

## 10. AUDIT

Collins Aerospace may, from time-to-time during the term of this License and up to 2 years after the expiration or termination of this License, require an audit be conducted to determine Licensee's compliance with the License terms and conditions. Licensee will be notified at least two weeks in advance of the time period to be covered by the audit and when the audit will occur. The audit will take place at Licensee's facilities during business hours on weekdays. The audit will be performed by a third party selected by Collins Aerospace. Licensee, at its own expense, will provide all records, documentation, and support required for the auditor to determine if the usage of the licensable Software and any required reporting or payments or both are in compliance with the License terms and conditions. Collins Aerospace will pay the auditor's fees unless the audit determines Licensee has not complied with the terms and conditions of this License. If Licensee is found not to be in compliance with this License, Licensee will pay the auditor's fees, transportation, sustenance and lodging costs for the audit performed and for the audit report. In addition, the Licensee will:

- (i) Pay any applicable then current license fees associated with use of the licensed Software which are due but not previously paid, and if the discrepancy is found to be more than 5% for any 3month period, the Licensee will pay liquidated damages of 150% the amount of the underpayment per 3-month period for which a greater than 5% discrepancy is found. Licensee will also pay the auditor's fees, transportation, sustenance, and lodging cost for the audit performed that uncovered the greater than 5% discrepancy and will also pay for the audit report itself. The rectification amount, the liquidated damages, and the auditing costs will be due within 30 days of invoicing. If payment for these amounts is not received within 30 days of invoicing, Licensor, at its sole discretion, may terminate this license.
- (ii) Generate, at Licensee's expense, a corrective action plan to prevent any reoccurrence of the non-compliance.
- (iii) Provide, at Licensee's expense, a corrective action plan to Collins Aerospace that is acceptable to Collins Aerospace.
- (iv) Implement, at Licensee's expense, the corrective action plan.
- (v) Pay all auditor's fees, transportation, sustenance and lodging costs for the next audit of Licensee.

Failure to comply with the provisions of this Section may result in termination of this License, in Collins Aerospace sole discretion.

If any follow up audit finds Licensee to be non-compliant with any of the terms of this License, then Collins Aerospace, at its option, may terminate this License and all other licenses that may exist between Licensee and Collins Aerospace immediately upon written notice to Licensee.

This Section in its entirety survives termination or expiration of this License

## 11. VALIDITY OF THE AGREEEMENT

This Agreement shall be valid from the date indicated in the Specific Conditions and for the duration set forth in the Specific Conditions, unless terminated earlier in accordance with Article 12 of the Agreement.

## 12. TERMINATION

- 12.1 Licensor shall be entitled to terminate in writing this Agreement if:a) Licensee is in breach with any of its commitments set forth in this Agreement;
  - b) Licensee enters (whether voluntarily or otherwise) into any bankruptcy proceeding, which may cause Licensee to be liquidated, reorganized, to cease its business or to make any arrangement with its creditors (in the event the suitable authority accepts said termination), within the limit of the applicable law.
- 12.2 All rights and licenses granted hereunder by Licensor to the Licensee shall be terminated automatically and immediately as from the date of sending of Licensor's termination letter. Without prejudice to the above, Article 5 of the Agreement shall survive the termination of the Agreement.
- 12.3 Such termination shall not extinguish any other remedies which Licensor may have with respect to such breach, and it shall not relieve Licensee of any obligation accrued as of the date thereof.
- 12.4 Within thirty (30) days following any termination of this Agreement, Licensee shall return to Licensor all copies of the Licensed Software

or, upon request by Licensor, shall destroy all copies of Licensed Software and certify such destruction in writing.

Upon termination of this Agreement, the Licensee shall discontinue use of the Software, return to Licensor all copies of the Software, the master and any related documentation or, upon request by Licensor shall destroy all copies of the Software and certify such destruction in writing.

# 13. CRYPTOGRAPHY AND IMPORT/EXPORT REGULATION COMPLIANCE

Licensee acknowledges that the Licensed Material may contain information subject to export restrictions. Licensee will not ship, transfer, or export to any country or individual, or use the Licensed Material in any manner prohibited by the United States Export Administration Act or any other applicable United States export laws, restrictions or regulations including those of the Office of Foreign Asset Control (OFAC). Licensee will comply with the OFAC regulations as if it were a U.S. Person under those regulations, including the provision of services or retransfer of the Licensed Material to any persons or companies listed on the Specially Designated Nationals and Blocked Entities List.

Licensee shall comply with all applicable import/export control laws applicable to the Software.

In particular, attention of Licensee is drawn on the fact that, depending on the option chosen by Licensee in the Specific Conditions, this Software may use strong cryptography, so even if it is created, maintained and distributed from liberal countries in Europe (where it is legal to do this), it falls under certain export/import and/or use restrictions in some other parts of the world.

Also, as a dual use item under European Export regulations, the potential export from France of encryption means may requires prior export authorization/license from the French Authorities. Licensor will make its best efforts to make application for the French export license /authorization if so required, to be able to export the encryption means to Licensee's country.

But then it will be Licensee's responsibility to obtain any other required authorization, import license or clearance from relevant authorities, to be able to import, re-export or operate the Software with the aircraft. In no event shall Licensor be liable for any French government's delay, refusal, and withdrawal of any such license or authorization. These events shall be considered as Force Majeure events. Licensor and Licensee shall cooperate with and assist each other in securing any such authorization or license.

PLEASE REMEMBER THAT EXPORT/IMPORT AND/OR USE OF STRONG CRYPTOGRAPHY SOFTWARE, PROVIDING CRYPTOGRAPHY HOOKS OR EVEN JUST COMMUNICATING TECHNICAL DETAILS ABOUT CRYPTOGRAPHY SOFTWARE IS ILLEGAL IN SOME PARTS OF THE WORLD. # 14. LAW AND JURISDICTION

This License will be governed by and interpreted in accordance with the laws of the State of New York, U.S.A., but without consideration of the state's conflict of laws principles and specifically excluding the provisions of the United Nations Convention on Contracts for the International Sale of Goods, as amended by protocol.

#### 15. MISCELLANEOUS

Licensee shall not be entitled to assign or transfer its rights and obligations relating to the Software under this Agreement without the prior consent of Licensor.

Licensor reserves the right, in its sole discretion and from time to time, to revise or update Software. Each such update or revision by Licensor shall also be considered Software subject to the terms of this Agreement.

The provisions of this Agreement shall be severable, and invalidity of any provision shall not affect the validity of the rest of this Agreement. Licensee acknowledges that it has read this Agreement, understands it and by using and/or installing the Software agrees to be bound by its terms and conditions. Licensee further agrees that it is the complete and exclusive statement of the Agreement between Licensee and Licensor which supersedes any proposal or prior agreement, oral or written, and any other communications between Licensee and Licensor relating to the subject matter of this Agreement.
