Rockwell Collins currently holds a Type 2 Letter of Acceptance (LOA) that acknowledges compliance with Advisory Circular AC 20-153B regarding aeronautical data processing, Refs. (B) thru (F). The acceptance of this LOA is based upon compatibility with specific equipment. Rockwell Collins maintains a list that identifies systems for which compatibility has been established. We are requesting your concurrence to use an updated list of systems.

The List of Applicable Flight Management Computer (FMC) Part Numbers, dated 24 November 2020 has been previously submitted to your office and approved, Ref. (F). The List of Applicable Flight Management Computer (FMC) Part Numbers, dated 23 March 2021 is being submitted to your office with this package.

The updated list recognizes the new AFD-3730 Adaptive Flight Display which has been submitted to and approved by your office, Ref. (G) and Ref. (H). One Flight Management System Application (FMSA) reference was also added for the AFD-3710 Adaptive Flight Display. A complete summary of the additions is identified in the table below.
