GENERAL TERMS AGREEMENT

THIS GENERAL TERMS AGREEMENT (Agreement) is entered into by and between Rockwell Collins, Inc., a part of Collins Aerospace, ("Seller") and the undersigned Buyer, and is effective as of the date of acceptance hereto. Seller and Buyer are herein referred to separately as "Party" and together as "Parties". This Agreement specifies the aviation related services ("Services") that Seller performs or arranges for user ("Buyer"), from time to time, at the request of the Buyer.

"Work Product" means any computer software (object code or source code), databases, documentation, inventions, analyses, studies, recommendations, reports, plans, results, data compilations and other media, materials, objects, information and intellectual property produced as a result of the Services provided and/or delivered by Seller, its employees, agents and subcontractors, in the course of providing the Services, including without limitation the use of any datalink, planning, analytical or predictive tool provided by Seller within the Exhibits.

SERVICE AGREEMENTS.

This Agreement is intended to be the overriding Agreement for Services between the Parties. The term "Services" shall mean data, software, information or subscription services procured by Buyer in applicable Service Agreements. Specific terms for specific Services are addressed in separate exhibits ("Exhibits") attached hereto.

TAXES.

Except as otherwise specified, the prices stated do not include any state, federal, or local sales, use or excise taxes applicable to the sale and provision of Services sold hereunder, including, as applicable, associated software delivered with such Services, and the Buyer expressly agrees to pay to Seller, in addition to the prices stated, the amount of any such taxes, domestic or foreign, which may be imposed upon or payable by Seller.

3. TERM AND TERMINATION.

Unless otherwise specified in an Exhibit, each Service Agreement shall be valid for a period of one (1) year from the date last signed by the Parties and will automatically renew for an additional one-year period with paid invoice at the end of the first year and at the end of each subsequent one-year period. The general terms in this Agreement shall remain in effect throughout each subsequent renewal period unless new terms are provided by Seller. (A) Either Party may terminate this Agreement for convenience with written notice ninety (90) days prior to the anniversary date of the renewal at no additional cost to Buyer. Should Buyer terminate the Agreement with written notice ninety (90) days prior to the anniversary date of the renewal, Buyer shall not receive any monies in a refund and/or credit for any unused portion of the cancelled subscription. (B) Should Buyer terminate the Agreement for convenience at any time other than provided in Section 3(A), Buyer shall not receive any monies in a refund and/or credit for any unused portion of the cancelled subscription. (C) Either Seller or Buyer can terminate this Agreement should any party materially fail to perform or observe any covenant, condition, or agreement to be performed or observed and such failure is not corrected or diligently prosecuted within ninety (90) days after written notice thereof. Should either Seller or Buyer terminate this Agreement, Buyer shall not receive any monies in a refund and/or credit for any unused portion of the cancelled subscription. (D) Upon termination of this Agreement for any reason and at any time whatsoever, the licenses granted shall immediately terminate and Buyer shall cease to have any rights or licenses whatsoever to use the Aircraft Information Services. (E) In the event of termination, Buyer shall be responsible for payment of all usage charges incurred for any Service up to the date of termination. Seller is entitled to collect on any unpaid invoices and Buyer shall be obligated to pay the unpaid portion stated on such outstanding invoices

4. CONFIDENTIAL INFORMATION.

The information, data, text, software (object code and source code), music, sound, photographs, graphics, video, messages or other material presented or disclosed by the Seller to Buyer ("Content") either in tangible form, in electronic form via software systems, or on the website hosted at www.rockwellcollins.com ("Website"), and any affiliated websites or systems that may be contained therein, are copyrighted under various law and may not be used without the written permission of Seller. All Content is owned by Seller and various third parties. Nothing contained herein or on the Website should be construed as granting, by implication, estoppel, or otherwise, any license or right to use any of the Content without the written permission of Seller or such other party that may own the Content. Any copying, distribution, retransmission or modification of Content, whether in electronic or hard copy form, without the express prior written permission of Seller is strictly prohibited. Buyer agrees to not: (i) sublicense, assign, translate, rent, lease, lend, resell for profit, distribute or otherwise assign or transfer the Content, or access to the Website to others; (ii) decompile, reverse engineer, disassemble, modify, reduce the Website or Content to source code form or create derivatives works based upon the Website, the Content, or any part thereof; (iii) merge the Website, or Content with another program or create derivative works based on the Website or Content; (iv) remove, obscure, or alter any notice of the copyright or other propriety legends on the Website, or Content; (v) disable any licensing or control features of the Website or Content; (vi) use, or allow the use of, the Website, or the Content in contravention of any federal, state, local, foreign or other applicable law, or rules or regulations of regulatory or administrative organizations; (vii)

introduce into the Website or Content any virus or other code or routine, including without limitation any virus or other code or routine intended to disrupt or damage the Website, alter, damage or delete any Content, or retrieve or record information about the Website or its users; or (viii) otherwise act in a fraudulent, malicious or negligent manner when using the Website or Content.

During the term of this Agreement, information provided by Buyer to Seller will be treated as confidential and shall not be utilized by Seller without Buyer's written consent and approval.

PAYMENT AND INVOICING.

Standard payment terms are net thirty (30) days, unless specified otherwise. Notwithstanding any statement of terms or time of payment to the contrary appearing in an Exhibit attached hereto, Seller reserves the right to require payment in advance of service delivery or shipment or to ship C.O.D. In the event Buyer fails to pay any invoice when due, in addition to any other right reserved hereunder, Seller reserves the right to suspend or limit performance until all past due sums are paid. Further, Seller reserves the right to charge interest at the rate of one- and one-half percent (1.5%) per month, or the maximum rate permitted by law, whichever rate is lower, on any unpaid balance owing by Buyer from the date due until the date paid.

6. DELIVERY.

Unless otherwise specified, goods requiring physical delivery will be made EXW (Incoterms 2000) the place or location of Seller's factory or office from which Seller elects to make shipment, according to the delivery schedule specified which schedule is subject to delays due to causes beyond Seller's control. Cancellation or rescheduling of the delivery by Buyer may be subject to additional charges by Seller.

7. FORCE MAJEURE (EXCUSABLE DELAY).

Seller shall not be liable for default or for delay in deliveries due to causes including those beyond its control and without its fault or negligence, including but not limited to inability to obtain material, labor or manufacturing facilities, acts of God, or of the public enemy, any preference, priority or allocation order issued by the Government, changes in applicable law or any other act of Government, fires, floods, unusually severe weather, epidemics, quarantine restrictions, strikes, freight embargoes, or delays of Seller's suppliers. In the event of such delay, delivery dates shall be extended accordingly for a period equal to the time lost by reason of such delay. Seller shall use its reasonable efforts to remove the cause of delay and resume work as soon as possible and to mitigate delivery schedule delay. In no event shall Seller be liable for any damages. Seller reserves the right to provide, at no change in price, substitute Services of equal or better capability provided however that such substitute Services maintain functionality of the original Services.

8. PROVISION OF SERVICES.

Each request for Services made by a Buyer or Buyer representative, who contacts Seller to arrange for the procurement of Services, represents a commitment by Buyer to pay for Services received at Seller's then current Price List. A request for Services may be oral or written and may be transmitted in any media. Seller will confirm such request in writing within thirty days of receipt. Seller's record of requests for and provision of Services will be presumed correct. Buyer consents to the Seller arranging the provision of any of the Services directly to the Buyer by third-party suppliers ("Suppliers") or by entities under common control with Seller ("Affiliates"). Seller shall not be responsible for the performance of Services delegated to Suppliers or Affiliates.

9. EXPORT.

The parties agree to abide by all US Government laws and export regulations, including without limitation those applicable to re-export, and when required by such laws or regulations, Buyer shall apply for the necessary and appropriate export licenses. Seller shall, at no charge to Buyer, promptly provide reasonable support and documentation if required for such export license application.

10. ARBITRATION.

For Buyers outside of the United States, any dispute, controversy, or claim arising out of or relating to this Agreement, its breach, termination, invalidity, whether based in contract, tort or any other legal or statutory claim, (each, a "Dispute") shall be resolved in accordance with the procedures specified herein, which shall be the sole and exclusive procedure for the resolution of any such Dispute. The parties to the Dispute will attempt in good faith to resolve any Dispute promptly by negotiations between executives of the parties who have authority to settle the controversy. If the Dispute is not resolved within a period of ninety (90) days, then, upon written notice by either party to the other, the Dispute shall be resolved by binding arbitration in accordance with the International Arbitration Rules of the International Centre for Dispute Resolution ("ICDR"). All decisions will be in accordance with the substantive laws of the State of lowa, U.S.A. (excluding choice of law) and the arbitration shall be conducted in the State of Iowa. The English language shall be used. Within fifteen (15) days after the commencement of the arbitration, each party shall select one person to act as arbitrator and the two selected shall select a third arbitrator within ten (10) days of their appointment. If the arbitrators selected by the parties are unable to or fail to agree upon

the third arbitrator, the third arbitrator shall be selected by the ICDR. The arbitral panel shall decide each issue presented to it by majority vote, and the arbitral panel's decisions shall be in writing and shall be final and conclusive. All arbitrators shall serve as neutral, independent, and impartial arbitrators. The amount of the fees of the arbitration (including legal fees and expenses) and by whom they shall be paid will be determined as part of the arbitration. Judgment on the award rendered by the arbitral panel may be entered in any court having jurisdiction thereof. Either party may apply to the arbitral panel seeking injunctive relief until the arbitration award is rendered or the controversy is otherwise resolved. Either party also, without waiving any remedy under this Agreement, may seek from any court having jurisdiction any interim or provisional relief that is necessary to protect the rights or property of that party, pending the establishment of the arbitral panel.

11. WARRANTY.

Seller warrants that the Work Product delivered will substantially provide the functions set forth in the applicable specification. Jeppesen Terms and Conditions

The Navigation Database and the Obstacle Database licensed to Customer by RCI contain certain Jeppesen data, specifically NavData and Obstacle Data, both as defined below. All NavData and Obstacle Data incorporated into the Navigation Database and the Obstacle Database are subject to these Jeppesen Terms and Conditions.

Customer acknowledges and agrees that Boeing Digital Solutions, Inc., d/b/a Jeppesen, and its affiliates ("Jeppesen") are third party beneficiaries and are entitled (and will be deemed to have accepted the right) to enforce the terms of the agreement between Customer and RCI for the Navigational Database and the Obstacle Database specifically including these Jeppesen Terms and Conditions.

"NavData" means electronic flight navigation data compiled by Jeppesen in an electronic database, based on information from government sources, other publicly available sources, and/or information and data supplied by licensees, which may upon request of Customer also contain Tailored Data. NavData may not contain data on all aviation facilities, fixes, routes and other items of aeronautical interest in the world.

"Obstacle Data" means data depicting the location and height of certain obstacles which extend above a defined surface. Obstacle Data is for situational awareness and reference use only. It is based on information from government and other publicly available sources.

1. ASSUMPTION OF RISK. CUSTOMER EXPRESSLY ACKNOWLEDGES AND AGREES THAT USE OF THIS DATA IS AT CUSTOMER'S SOLE RISK AND THAT THE ENTIRE RISK AS TO SATISFACTORY QUALITY, PERFORMANCE, SAFETY, ACCURACY AND EFFORT IS WITH CUSTOMER.

2. LIMITATION OF LIABILITY.

DISCLAIMER AND RELEASE. THE CONDITIONS, REPRESENTATIONS, GUARANTEES, OBLIGATIONS, LIABILITIES AND WARRANTIES (IF ANY) OF JEPPESEN AND REMEDIES OF CUSTOMER SET FORTH HEREIN ARE EXCLUSIVE AND IN SUBSTITUTION FOR, AND CUSTOMER HEREBY WAIVES, RELEASES AND RENOUNCES, ALL OTHER WARRANTIES, CONDITIONS, REPRESENTATIONS, GUARANTEES, OBLIGATIONS AND LIABILITIES OF JEPPESEN, AND ANY OTHER RIGHTS, CLAIMS AND REMEDIES OF CUSTOMER AGAINST JEPPESEN, EXPRESS OR IMPLIED, ARISING BY LAW, EQUITY OR OTHERWISE, WITH RESPECT TO THE NAVDATA AND THE OBSTACLE DATA PROVIDED HEREUNDER AND ANY NONCONFORMANCE OR DEFECT IN THE DESIGN. ADEOUACY, ACCURACY, RELIABILITY, SAFETY, OR CONFORMANCE WITH GOVERNMENT STANDARDS OR REGULATIONS OF SUCH NAVDATA, OBSTACLE DATA OR OTHER THINGS PROVIDED HEREUNDER, INCLUDING BUT NOT LIMITED TO:

- (i) ANY IMPLIED WARRANTY OF MERCHANTABILITY, SATISFACTORY QUALITY, OR FITNESS;
- (ii) ANY IMPLIED WARRANTY ARISING FROM COURSE OF PERFORMANCE, COURSE OF DEALING OR USAGE OF TRADE;
- (iii) ANY OBLIGATION, LIABILITY, RIGHT, CLAIM OR REMEDY ARISING IN STRICT LIABILITY OR IN TORT, WHETHER OR NOT ARISING FROM THE NEGLIGENCE OF JEPPESEN; AND
- (iv) ANY OBLIGATION, LIABILITY, RIGHT, CLAIM OR REMEDY FOR LOSS OF OR DAMAGE TO ANY PROPERTY OF CUSTOMER, INCLUDING WITHOUT LIMITATION ANY AIRCRAFT.
- B. EXCLUSION OF SPECIFIED LOSSES AND DAMAGES. JEPPESEN WILL HAVE NO OBLIGATION OR LIABILITY WHATSOEVER, (i) WHETHER ARISING IN LAW, EQUITY, CONTRACT (INCLUDING BUT NOT LIMITED TO WARRANTY), TORT (INCLUDING BUT NOT LIMITED TO THE NEGLIGENCE OF JEPPESEN), STRICT LIABILITY, OR OTHERWISE AND (ii) WHETHER SUCH LOSSES OR DAMAGES ARE DIRECT, INDIRECT OR OTHERWISE, FOR:
 - (i) LOSS OF USE, REVENUE, PROFIT, ANTICIPATED SAVINGS, BUSINESS VALUE, OPPORTUNITY OR GOODWILL;
 - (ii) LOSS OR DAMAGES RESULTING FROM BUSINESS INTERRUPTION;
 - (iii) LOSS OR DAMAGES RESULTING FROM DELAY IN PERFORMANCE AND COST OF SUBSTITUTE PROCUREMENT;
 - (iv) LOSS OR DAMAGES RESULTING FROM REPRODUCTION OR RECOVERY OF DATA OR INFORMATION WHICH IS LOST, CORRUPTED OR DAMAGED IN ANY OTHER MANNER, WHETHER IN WHOLE OR IN PART; OR
 - (v) ANY INDIRECT, INCIDENTAL, CONSEQUENTIAL, SPECIAL, EXEMPLARY, PUNATIVE, OR PURE ECONOMIC LOSSES OR DAMAGES

IN ANY WAY ARISING OUT OF OR RELATED TO THIS AGREEMENT.

For purposes of this Section, the term "Jeppesen" means (i) Jeppesen, (ii) The Boeing Company, (iii) their respective parents, subsidiaries, and affiliates, (iv) the assignees of each, and (v) their respective directors, officers, contractors, licensors, subcontractors, employees and agents.

If a court of competent jurisdiction determines that applicable law implies warranties and liabilities which cannot be excluded or limited or which can only partly be excluded or limited, then the limit

on Jeppesen's liability set forth in this Section will apply to the fullest extent permitted by law. If Jeppesen cannot exclude or limit a warranty or liability implied by law, this agreement will be read and construed subject to such provisions of law.

3. INDEMNIFICATION. Customer will indemnify and hold harmless Jeppesen and its licensors, contractors, subcontractors and agents from and against all claims and liabilities (including claims by third parties), and costs and expenses (including attorneys' fees), incident thereto or incident to successfully establishing the right to indemnification, for injury to or death of any person or persons, including employees of Customer but not employees of Jeppesen, or for loss of or damage to any property, including without limitation any aircraft, arising out of or in any way relating to the utilization and/or processing of the NavData, Obstacle Data, or any other things provided hereunder, whether or not arising in strict liability or tort or occasioned by the negligence of Jeppesen, except to the extent of any obligation, liability, claim or remedy in tort due to the reckless misconduct of Jeppesen. Customer's obligations under this indemnity will survive the expiration, termination, completion or cancellation of this agreement.

For purposes of this Section, the term "Jeppesen" means (i) Jeppesen, (ii) The Boeing Company, (iii) their respective parents, subsidiaries, and affiliates, (iv) the assignees of each, and (v) their respective directors, officers, contractors, licensors, subcontractors, employees and agents.

4. EXPORT COMPLIANCE. Customer is responsible for its compliance with any applicable export control restrictions, laws and regulations as may be modified from time to time, imposed by the governments of the United States and, if applicable, other countries. Customer will not attempt to, or knowingly export or re-export the data or any products using such data covered this agreement to any country, or national thereof, prohibited from obtaining the data, either directly or indirectly through affiliates, licensees or subsidiaries of Customer.

- 5. ADDITIONAL INFORMATION ABOUT NAVDATA.
- A. NavData has been developed to meet the need for current aviation information in a computer compatible form required for (a) air navigation equipment used under instrument and visual flight conditions and (b) computerized flight planning applications. Information contained in NavData is independently available from publications of the appropriate governing authority.
- B. NavData is designed for use by experienced and knowledgeable (a) pilots who must be thoroughly familiar with and competent in, among other things, the navigation of aircraft and the air navigation equipment being used, and (b) flight dispatchers, flight planners and others who must be thoroughly familiar with and competent in, among other things, the planning of flights and the computerized flight planning programs being used. NavData does NOT contain all information necessary to independently conduct instrument or visual flight procedures or plan all aspects of a flight. NavData must be used in conjunction with the appropriate aeronautical charts and other information available to pilots, flight dispatchers, flight planners and others through a variety of sources. Pilots must conduct flight procedures in accordance with the information depicted on aeronautical charts.
- C. NavData is compiled in accordance with the industry recommended standard for aeronautical data, Aeronautical Radio, Inc. Specification 424, Navigation System Data Base ("ARINC 424"), and a

similar Jeppesen supplemental specification. Determination of the NavData elements used in Customer's avionics system is a joint effort between Jeppesen and the avionics manufacturer. Jeppesen NavData is transformed by the avionics manufacturer into formats and configurations necessary for use in the avionics system using computer programs designed, developed and controlled by the avionics manufacturer. JEPPESEN MAKES NO WARRANTY, AND SPECIFICALLY DISCLAIMS ANY WARRANTY, WHETHER EXPRESS OR IMPLIED, ARISING BY LAW OR OTHERWISE, AS TO THE PROPER USE, FUNCTION OR COMPLETENESS OF THE NAVDATA IN ANY SPECIFIC AIR NAVIGATION EQUIPMENT, OR IN GROUND BASED COMPUTER SYSTEMS AND PROGRAMS USED TO TRANSFORM NAVDATA INTO FORMATS AND CONFIGURATIONS NECESSARY FOR USE IN SPECIFIC AIR NAVIGATION EQUIPMENT.

- D. Some information displayed by the avionics system may be solely generated by the avionics system, and may not be information derived from NavData. NavData may not contain all of the navigation data existing worldwide, and Customer should make no assumption otherwise. The avionics system and the avionics manufacturer's packing software ("PSP") may not utilize all NavData available from Jeppesen, and the NavData provided hereunder may be only a subset of the data available from Jeppesen or the avionics manufacturer.
- 6. GENERAL ACKNOWLEDGEMENTS. Customer acknowledges and agrees that:
- A. Customer is the "end-user" of the data that is the subject of this agreement, and that Requirements and Technical Concepts for Aviation, Inc. (RTCA) document DO-200A and European Organization for Civil Aviation Equipment (EUROCAE) document ED-76, "Standards for Processing Aeronautical Data," Section 1.4, Application of Standard, state that, "The ultimate responsibility of ensuring that data meets the quality for its intended application rests with the end-user of that data."

8. LIMITED WARRANTY.

A. NAVDATA. JEPPESEN EXPRESSLY WARRANTS FOR THE SOLE BENEFIT OF CUSTOMER THAT IT HAS ACCURATELY COMPILED, REPRODUCED AND PROCESSED THE DATA OBTAINED FROM GOVERNMENT, CUSTOMER OR OTHER SOURCES INTO JEPPESEN NAVDATA AS SUPPLEMENTED AND/OR REPLACED BY ALERTS AS DESCRIBED ABOVE. THIS EXPRESS WARRANTY, WHICH IS EFFECTIVE ONLY FOR THE APPLICABLE 28-DAY PERIOD FOR WHICH THE NAVDATA IS PRODUCED AND IS EFFECTIVE, IS THE ONLY WARRANTY, EXPRESS OR IMPLIED, ARISING BY LAW OR OTHERWISE, MADE BY JEPPESEN REGARDING ITS NAVDATA. JEPPESEN'S SOLE OBLIGATION UNDER THIS WARRANTY IS LIMITED TO THE USE OF ITS COMMERCIALLY REASONABLE EFFORTS TO CORRECT ANY ERRORS AND PROVIDE

A CORRECTED VERSION OF THE NAVDATA AS SOON AS REASONABLY PRACTICABLE. THIS SECTION STATES CUSTOMER'S SOLE AND EXCLUSIVE REMEDY FOR BREACH OF THIS WARRANTY.
