

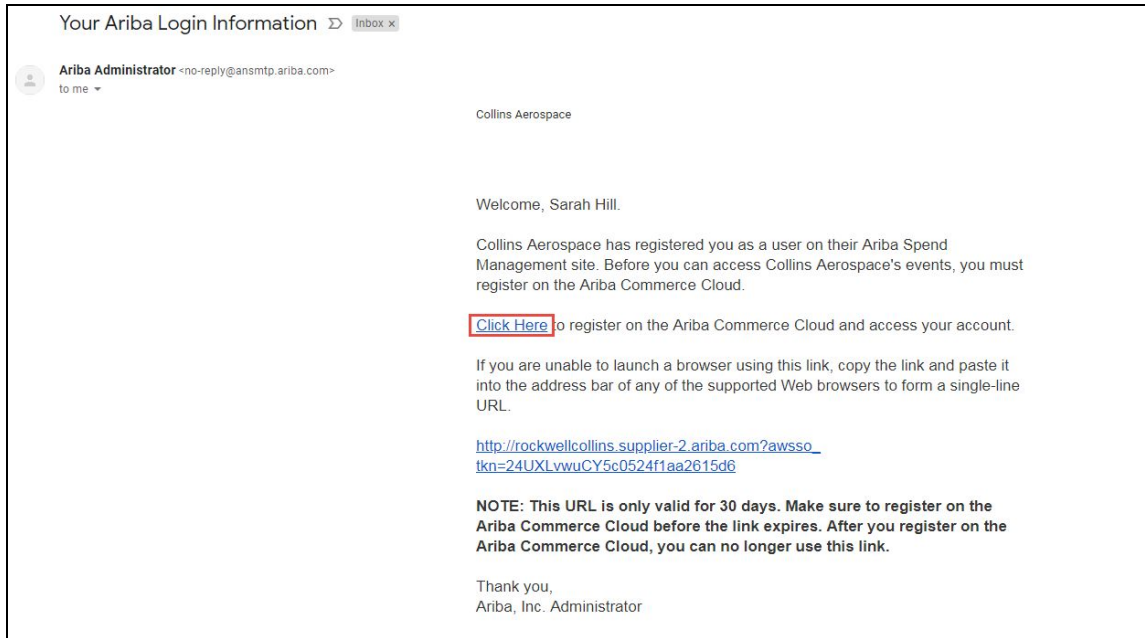

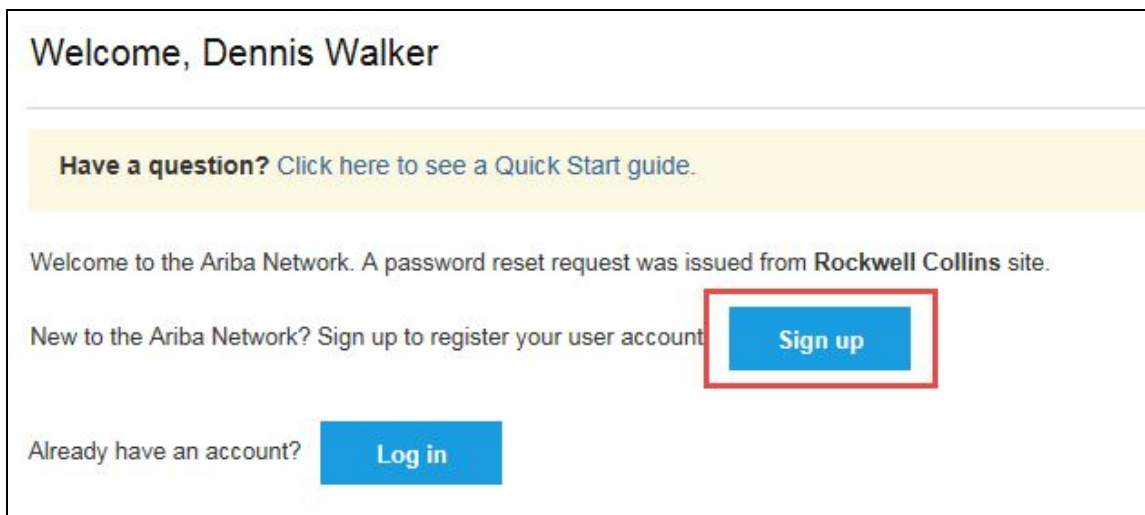
2.1 Click on the “Click Here” link included in your registration email (from Ariba Commerce Cloud).
